Citing Electronic Resources in APA Format

When citing an electronic source, include the same information you would for a print resource (author, title, etc.). Direct readers as close as possible to the information being cited. Verify your URLs prior to submitting your bibliography.

Electronic Periodical Articles: including Journals, Magazines or Newspapers

Based on The Publication Manual of the American Psychological Association (APA) (6th edition) (Ref 808.02 A512 2010)

Electronic periodical articles are primarily available through PROPRIETARY DATABASES. Libraries pay a fee for subscriptions to these databases. Although these databases are posted and accessible via the Internet, don't confuse them with general web sites. Examples of how to cite articles from databases, ejournals and Internet articles are listed below.
